MESSAGE FROM THE CEO

Since joining IJM in April 2024, I have been inspired by the incredible community of passionate Australians who have used their resources, time and voices to make giant strides forward in the fight against slavery.

I had the privilege of visiting our field office in Thailand earlier this year. A question that came up repeatedly during this trip was "What does it mean to live outside the protection of the law?" As we drove past a home and a factory that marked former places of captivity and oppression, and later got the opportunity to meet a survivor of forced scamming, I got a clear image of the devastating answer to this question. But whilst these experiences highlighted the depth of the problem, I was also encouraged by the brilliance of the solution that IJM offers. IJM work with prosecutors and other justice system officials to ensure that traffickers and perpetrators are held accountable, stopping the cycle of violence and deterring others from abusing vulnerable people addresses the root of the issue.

Australia's Unique Position

In Australia, we have a unique opportunity to be part of the solution of various tech-fueled forms of modern slavery. Scams affect countless Australians but are often sent by victims of scams themselves, trapped in massive compounds in Southeast Asia. Child abuse through a webcam is paid for by Western men, including Australians. The global nature of these crimes is undeniable. It highlights that it is now more important than ever to rally more Australians behind our mission and invite corporations, governments, and entire communities into our fight for justice.

Survivors Creating Change

I am deeply moved by the many survivors that were once oppressed in slavery and violence. They were

not only able to escape captivity but are now thriving in freedom. Many survivors are becoming advocates of change themselves, as we can see in the growth and founding of many new chapters of the Global Survivor Network in the past year. As these survivors call for the freedom of others, advocate for change to government and corporations, are involved in designing groundbreaking studies and inform postrescue processes, I am reminded of the powerful voice survivors of slavery and violence hold.

I encourage you, as you read this report, to keep in mind that behind every number is a real person.

With your partnership, we can continue to build a profound movement that works to strengthen justice systems and ends slavery once and for all.

MESSAGE FROM THE BOARD CHAIR

Over the last 26 years, IJM has seen over 95,000 rescues – that's 95,000 lives that are forever changed. But IJM's vision does not stop at rescue. We are strengthening justice systems so that people are protected from violence in the first place. Together, we are working to create a world where freedom and justice prevail.

In December 2023, IJM officially registered our newest program office in Dhaka, Bangladesh. Together with local authorities and civil society, we will combat human trafficking in various regions of the country, seeking to protect more than 50 million people in Bangladesh from exploitation by 2030.

This year, we celebrated the significant milestone of reducing child sex trafficking by 78% in the Dominican Republic. This is the most recent of nine programs to successfully and sustainably protect vulnerable people from violence at scale. Now more than 340,000 children in the Dominican Republic are safe from ever being trafficked in the first place. It shows that transformation is possible and marks the conclusion of our program work in the Dominican Republic.

As we celebrate the opening of an office in one part of the world and the completion of work in another part, I am reminded of what is at the core of IJM's work: Strengthening local justice systems. Once justice is maintained independently, our work is complete.

And we cannot do it alone.

As IJM strives towards building safer communities where everyone can live freely without fear of violence or slavery, we will continue to equip partners to join us, mobilise advocates to demand justice and ask governments and corporations to help end slavery in our lifetime. We rely on the support of passionate Australians who are committed to growing the justice movement.

Following the close of this financial year, we are delighted to welcome David Braga as the new Chief

Executive Officer of IJM Australia. David brings a wealth of experience from the financial sector, coupled with a deep engagement in non-for-profits and a strategic vision. I am hopeful for the days ahead, and excited about the opportunities and impact that lie ahead under David's leadership.

Our Model

How we create lasting change: **Global Protection Model**

The global protection model is our working hypothesis of how to strengthen justice systems and achieve protection. It is intended for use by implementing partners and IJM staff when designing and implementing Justice System Strengthening Programs. The model is informed by the experiences of survivor and community leaders, host governments, implementing partners, IJM staff, corporations, international institutions, and data.

The global model describes best practices applicable across the geographies and case types where IIM works and serves as a framework and template for program teams to create their own context-specific models. Rather than spending energy to develop programming that other IJM programs have already established, program teams can focus their time and expertise on contextualising and implementing the model.

The Global Protection Model in Action



PHASE 1: GOVERNMENT **BUY IN**

Government engages with key stakeholders on protection.

PHASE 2: GOVERNMENT INVOLVEMENT

Government takes new actions to protect people in stakeholders

PHASE 3: GOVERNMENT INDEPENDENT CHANGE

Government takes independent actions to strengthen its response to slavery and violence.

PHASE 4: GOVERNMENT INFRASTRUCTURE

Government implements necessary conditions to address slavery and violence in a systemic matter.


PHASE 5: GOVERNMENT **PROTECTION**

Project targets met for increased justice system performance, decreased prevalence of the crime and improved confidence and reliance on the justice system.

How we operate: **Global Programs & Jurisdictions**

Under the umbrella of 12 global programs, we have identified 56 specific jurisdictions around the world to apply our model to. While these locations are spread out across continents, they all have two things in common: each jurisdiction contains horrific violence and the potential for dramatic transformation.

The ultimate goal of each jurisdiction is to strengthen local justice systems. When local justice systems are equipped and strengthened to maintain justice independently, our work is complete, and we close our office. Success for IJM looks like completed and closed offices in jurisdictions. We have already completed our work in nine jurisdictions with a successful 50%-86% decrease in violence and slavery of the targeted casework.



And we're not done yet.

IJM's teams around the world have a plan to expand this protection to millions more vulnerable people. Across the remaining 47 identified jurisdictions, drastic reductions in violence are possible, with the potential to protect 490 million more people from slavery and abuse.

The key areas of intervention by IJM and our partners include:



CASEWORK

Provides technical support to the justice system and local survivor services on individual cases and overall infrastructure.



SURVIVOR LEADERSHIP

Empowers and supports survivors in leading the movement against violence.



CAPACITY BUILDING

Provides training and supports government in developing sustainable systems to build and maintain institutional capacity.





DATA MANAGEMENT

Builds the capacity of the government to monitor protection on an ongoing basis.



NARRATIVE BUILDING

Builds community recognition of the problem, justice system improvements, and how to report incidents.



ADVOCACY

Takes strategic action directed at changing the policies, positions, practices, or programs of the government.



INDIA

A surprise inspection leads to freedom for 12 young boys forced to make jewelry 12 hours a day

With guidance and training from IJM, the local government in Tamil Nadu conducted a surprise inspection of a jewellery factory leading to the rescue of 12 victims of human trafficking and child bonded labour.

The boys were lured by advance payments of less than \$300 AUD, then forced to work 12-hour days in inhumane conditions. They were given official Release Certificates from the government cancelling their debts and stayed at a safe government-run shelter where they received aftercare until authorities arranged their safe return home.

SOUTHEAST ASIA

A new form of trafficking quickly emerges, and IJM is among the first responders to help fight it

Almost overnight, forced scamming has become one of the fastest-growing forms of human trafficking in the world. Vulnerable people in Southeast Asia desperate for a stable income are targeted online by promising job opportunities, only to be trapped in compounds against their will and forced to scam others online. If they don't comply or fail to meet quotas, they are often beaten, abused and in some cases tortured.

Over 200,000 people are believed to be trapped in forced scamming compounds right now in countries like Cambodia, Laos, Myanmar and the Philippines.

Our work to address forced scamming has been featured in international news stories from major news outlets like the BBC, spurring governments across the world to begin working together to combat this new cross-border crime.

In 2023, IJM helped to relieve more than 200 individuals from forced scamming within Southeast Asia's scam compounds.

CAMBODIA

IJM helps rescue 28 victims of forced scamming and arrange their safe return home

When a local IJM partner in Cambodia learned of a group of Indonesians suspected of being trafficked and forced to work at an online scam center, they immediately referred the case to the Indonesian embassy and local police.

This report kickstarted a collaborative, cross-border effort between IJM and several Cambodian and Indonesian authorities to locate and rescue the group. Within two weeks, they were found and rescued, and the process of repatriation began.

Survivors told police they were tricked online into travelling to Cambodia for jobs, only to have their passports confiscated upon arrival. They were physically beaten and abused when they didn't meet scamming quotas or made simple mistakes.

Thanks to IJM's collaborative work with local partners and authorities, not only were victims rescued but also received a range of support like counselling, interpretation services and even food and amenities while waiting for repatriation back home.

After rescue, healing can begin. With your partnership, IJM supports survivors as they set out on the journey of healing. As they experience restoration, they can thrive in their communities and become influential voices leading the fight against violence.



INDIA

A village once enslaved demonstrates the power of healing in community

For over three decades, an entire village called Amaragiri was enslaved by local businessmen who trapped them all in false debt. This small fishing town of about 100 people were forced to work and give almost all their earnings to the men who enslaved them in bonded labour.

When IJM's local partner discovered the crime and reported it to authorities, the government at first doubted that this could be happening. But after continued advocacy, they intervened. Authorities issued Release Certificates to all villagers in 2016, formally acknowledging their freedom from any false debts

Today the village is thriving, and recently celebrated seven years of freedom. IJM's local partner educated community leaders on their legal rights, including government resources available to them, to ensure that they would never be exploited again. Families now fish to earn income for themselves, children attend school, and neighbours support each other's needs. Under the protection of the government, Amaragiri has become a place where survivors flourish in safety.

PERU

Child survivors are reminded they are "More than Conquerors" at survivor-led retreat

A retreat hosted by IJM and local partner Paz y Esperanza welcomed 10 child survivors to participate in a week of hope, healing and transformation. The children, ranging from 10 to 18 years old, played games and made crafts to help provide them with peer support and social integration.

To teach the children to channel their pain to develop strength and resilience, a leader from the GSN chapter in Bolivia shared her own story of transformation. IJM will continue to work with GSN chapters and local partners to host these gatherings to strengthen community-based protection and ensure that children receive the support needed to avoid re-victimisation.

ROMANIA

Samara's* journey from abuse to restoration

For five years, Samara experienced a brutal cycle of abuse and sexual exploitation, being trafficked from Romania to the UK. Suddenly, back in Romania, the traffickers kicked her out of the house, Samara was finally free. She bravely went to the police. Her case was passed to a specialised human trafficking prosecutor, who had previously attended IJM training. He referred the case to IJM. IJM came alongside Samara with urgent psychological and legal support. Today, two years after IJM's support began, Samara is a strong and resilient mother who is focused on her family's future. With IJM's support, she's got her driver's license and completed a floristry course.

Samara reached another dream in November 2023 - marrying a man who loves and respects her. Samara and her husband are beginning their married life together with their children in a village in Romania.

PHILIPPINES

Trafficker gets four life sentences for online sexual exploitation of children

In November 2023, IJM Philippines saw a trafficker sentenced to four life terms — one of the strongest penalties ever imposed in a case of online child sexual exploitation (OSEC).

The court found the female trafficker guilty of trafficking, child abuse, and offering child sexual abuse material online. In addition to multiple life terms, the trafficker was sentenced to another 14 years in prison and fined 7.5 million Philippine pesos (over \$200,000 AUD).

IJM provided technical and legal support to government prosecutors on the case. IJM Cebu Director, Atty. Lucille

Dejito said: "This stands out as one of the most robust sentences we at IJM have witnessed in a conviction for a case of OSEC. Convictions like this help to intensify the deterrence of this crime."

The case first came to light when the Philippine
National Police received information from the Nordic
Police Liaison in Manila about the arrest of a Swedish
national who procured child sexual exploitation
material from the Philippines. When the Filipino
trafficker offered to sexually abuse her six-year-old son
and a one-year-old girl for profit, she was arrested, and
her son and daughter were rescued.

UGANDA

A 14-year-old survivor bravely stands up to the Army officer who assaulted her

Hana* was only a teenager when a military officer who knew the family exploited their trust and sexually assaulted her several times. When the family bravely reported the crime, the accused officer resisted arrest and drew a gun at the police investigating him.

Despite his intimidation tactics, IJM investigators worked with local authorities to support Hana's case and ensure the perpetrator would not escape justice. He was soon arrested, charged in court and sentenced to 14 years in prison.

Following the verdict, IJM Uganda Legal Coordinator Florence Lora Atim said "I believe this sentence will send a strong message out to the community that abuse of children is a crime."

DOMINICAN REPUBLIC

IJM helps reduce child sex trafficking by 78% in the Dominican Republic

When IJM's office in the Dominican Republic first opened in 2013, children were openly trafficked in the streets, on public beaches and in parks because traffickers had no fear of getting caught.

Today, that no longer happens. Perpetrators are too scared to traffic children, because law enforcement now has the training and resources needed to enforce local laws effectively. More children are being rescued and more perpetrators are being arrested and convicted for trafficking than ever before.

As a result, child sex trafficking across the country has been measurably reduced by 78%. That means more than 340,000 children in the Dominican Republic are now safe from ever being trafficked in the first place.

IJM's work to strengthen the local justice system in the Dominican Republic is the most recent of nine programs to successfully and sustainably protect vulnerable people from violence at scale.

The story behind the impact numbers from IJM's work in the Dominican Republic is similar to the eight successful programs that preceded it - a fundamental shift in culture. Traffickers are now afraid of consequences. During a recent study, undercover investigators posed as customers to see if they could purchase a minor for sex. One trafficker replied, "That's not allowed. The police will arrest you." Another trafficker responded, "It can't be done there."

ROMANIA

IJM and the Government of Romania host conference to unify European response against human trafficking

To improve measures to combat human trafficking across Europe, IJM worked with the Government of Romania to bring together high-ranking leaders from across the continent for an international conference.

IJM CEO Gary Haugen gathered with the US ambassador, the Romanian prime minister and other high-profile attendees around a common objective: combating cross-border human trafficking and finding solutions to incriminate the demand and combat human trafficking facilitated by technology.

The conference helped reinforce a high level of trust in IJM as expert partners and leaders in the fight against trafficking and encourage stronger cross-border networks that will one day help bring an end to trafficking in Europe.



MALAYSIA

IJM helps equip 180 local officials to provide victims of trafficking with trauma-informed care

Law enforcement officers and public prosecutors from six different departments and agencies in Malaysia came together for a comprehensive training session on the importance of a victim-centred approach to combating trafficking.

Law enforcement officials are typically trained to arrest perpetrators, but rescuing victims requires

THE PHILIPPINES

A groundbreaking new study from IJM sparks global conversation about OSEC

Online sexual exploitation of children (OSEC) is one of the hardest crimes to detect, meaning it's also one of the hardest to stop. Without a clear picture of how widespread OSEC is, it's impossible to know whether progress is being made to stop it.

This year, your support helped bridge that gap. In October, together with Nottingham Rights Lab, IJM released the Scale of Harm study that for the first time helps authorities better understand how perpetrators operate, how many children are at risk and how we can create a plan to end it for good.

The study revealed that in 2022 alone, 1 in 100 Filipino children were sexually exploited via livestream to create new abuse images and videos in the Philippines, driven by foreign demand.

These findings are a groundbreaking major step towards ensuring all children in the Philippines are no longer in danger of sexual exploitation. With more information in front of us, advocacy groups and government leaders are in a better position to urge the passing of online legislation to protect children in places like Europe, the U.K., the US, Canada and Australia where the demand for this material is generated.

GHANA

United Way and IJM join forces to fight human trafficking in Ghana

Recognising a shared vision of creating community-based solutions to fight human trafficking in Ghana, IJM and United Way began working together on "The Anti-Child Trafficking Project." This initiative supports Ghana's Global Survivor Network (GSN) chapter by providing comprehensive trainings on self-empowerment, human trafficking and the law, advocacy and the power of storytelling, public speaking and more.

Jerry, the president of a GSN chapter in Ghana called the "Courageous Crew", put the training he received to immediate use. When he received a call from a man who feared to work on Lake Volta, Jerry took what he learned and acted without hesitation.

Along with other Courageous Crew members, Jerry intercepted the children being trafficked at a local bus stop and contacted the police. Today, instead of performing life-threatening tasks on the lake, they are collecting their school supplies and uniforms in anticipation for school.

As IJM partners with aftercare workers, social services and governments to serve and care for victims, we believe that survivors are the experts who are shaping the path forward. The Global Survivor Network (GSN) is their platform to influence lasting change on a global scale.

Funding for Anti-Slavery Commissioner Approved

In May 2023, the government budgeted \$8 million over four years, plus \$2 million annually, to establish a federal Anti-Slavery Commissioner. This Commissioner will work with the government, industry, and civil society to support compliance with the Modern Slavery Act 2018, improve supply chain transparency, and combat modern slavery in Australia and abroad. In May 2024, Parliament passed legislation to officially create Australia's first national Anti-Slavery Commissioner.

Strengthening Australia's Online Safety Standards: IJM's impact on key changes and implementation

Over the past year, IJM advocated for stronger industry standards under Australia's Online Safety Act. IJM's recommendations led to key safety measures, including mandatory detection and removal of child sexual abuse material, disrupting livestreamed content, and ongoing investments in safety technologies and staff.

These measures, which apply to a wide range of digital services including the world's major platforms, also ensure protections extend to non-users at risk of harm and require service providers to report their actions, ensuring greater transparency and accountability. The industry standards were officially registered by Australia's eSafety Commissioner in June 2024.

During the past year, IJM has made great strides in fostering collaboration with the Australian Government to combat modern slavery and the online sexual exploitation of children. Here are some of the highlights.

September 2023

IJM hosted the US Ambassador-At-Large to Monitor and Combat Trafficking in Persons, Cindy Dyer, and Principal Deputy-Director of the US Office to Monitor and Combat Trafficking in Persons, Dr Kari Johnstone to discuss the importance of collaboration to counter the rise of forced scamming, and the new Australia-United States Joint Council on combatting online child sexual exploitation.



IJM Advocacy team held 18 meetings across seven days in Canberra with federal parliamentarians and public service representatives to press our case for strengthening Australia's Modern Slavery Act, strengthening online safety regulations to protect children from online sexual exploitation, and responding to the crisis of trafficking into online scam centres.

February 2024

Commonwealth Attorney-General, Hon Mark Dreyfus KC, MP, met with Attorney Samson Inocencio (IJM Regional Vice President, OSEC Hub, National Director, IJM Philippines and recent US Trafficking in Persons Hero Award recipient) and IJM team to discuss the ongoing collaboration between Australia and the Philippines in countering the online sexual exploitation of Filipino children.

March 2024

Attorney Samson Inocencio met with the Commander of the Australian Centre to Counter Child Exploitation (ACCCE), Helen Schneider, and IJM team in Brisbane. They discussed IJM's partnership with the ACCCE through the Philippines Internet Crimes Against Children Centre in Manila, where IJM and the Australian Federal Police collaborate with international law enforcement partners to apprehend perpetrators of OSEC and rescue victims.


